**ARTICLES OF INCORPORATION  
OF  
FLORIDA AFTER SCHOOL ACADEMICS AND RESEARCH, INC.**

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act hereby files the following Articles of Incorporation pursuant to Section 617.0202 Florida Statutes concerning not for profit corporations.

**ARTICLE I  
NAME**

The name of the Corporation shall be **Florida After School Academics and Research, Inc.** approved by the board of directors. The principal place of business shall be 20 N. Orange Avenue, Suite 1309, Orlando, Florida 32801.

**ARTICLE II  
TERM**

The term of existence of the Corporation shall begin on the day of filing, and shall continue into perpetuity, or until dissolved in a manner provided by law or by regulations adopted by the Chairman of the Board and Chief Executive Officer.

**ARTICLE III  
PURPOSE**

The purposes for which the Corporation is organized is to provide instructional aid to public school students that is designed to increase reading comprehension and mathematic skills that will assist in conquering academic standards set by the Florida Comprehensive Assessment Test and all other services necessary to carry out the functions of the Corporation, to engage in any activities and to transact any and all lawful business for which the Corporation may be incorporated under the Florida Not for Profit Corporation Act and/or permitted under laws of the

United States, doing business as **Florida After School Academics and Research, Inc.**

**ARTICLE IV  
COMMON STOCK**

There shall be no shares of common stock.

**ARTICLE V

## **ARTICLE IX BYLAWS**

The director shall adopt Bylaws at the first organizational meeting. The proposed Bylaws shall be approved by two thirds vote of the total board of directors before the law of the Corporation.

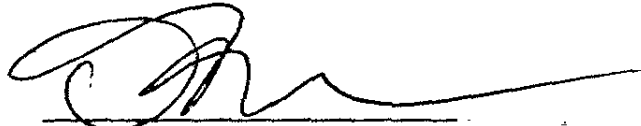
## **ARTICLE X TERMINATION**

Officers work at the pleasure of the board. A simple majority vote of the board is required to remove an officer. Once terminated as a board member or an officer, voids the member's right to participate in executive meetings, unless invited by majority vote. There will be one class of members.

**ARTICLE XI**

Upon liquidation of the corporation the assets will be returned to the donors.

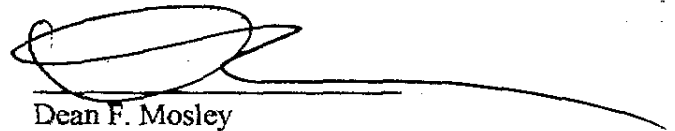

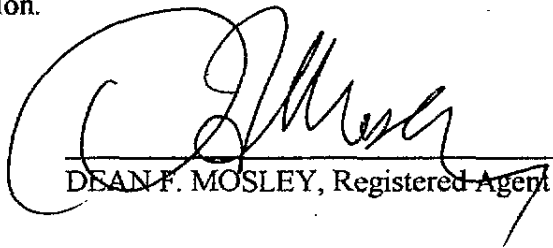
