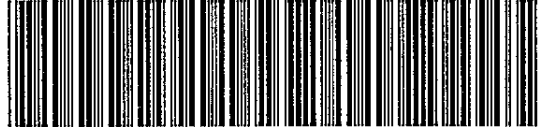



OF

We, the undersigned, hereby apply for the purpose of becoming a nonprofit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges, duties, and immunities of a corporation not for profit, under and pursuant to these Articles of Incorporation.

ARTICLE I

That the name of this nonprofit corporation is: **FRIENDS OF PUTNAM COUNTY DRUG COURT, INC.**

ARTICLE II

That the general nature of the business and objects and purposes to be transacted and carried on are that this nonprofit corporation may engage in any activity or business under the laws of the United States and of this State and the specific purpose is to allow volunteers to come forward and participate in the daily operations of drug court and in implementing programs; and to continue fund raising efforts; and to encourage the various governmental agencies in lending man power; and to insure the success in the continuation of the operations of drug court.

ARTICLE III

This nonprofit corporation shall have perpetual existence.

ARTICLE IV

The post office address of the principal office of this nonprofit corporation is 423 St. Johns Avenue, Palatka, Florida. The street address of the principal office of this nonprofit corporation is 423 St. Johns Avenue, Palatka, Florida 32177.

ARTICLE V

The number of directors of this nonprofit corporation shall be not less than seven (7) nor more than thirteen (13).

ARTICLE VI

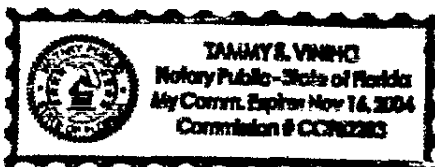
