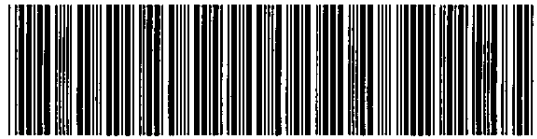

Article V - Dissolution

This corporation may be dissolved only by the agreement of two-thirds of the full Board of Directors. In the event of such dissolution the Board of Directors shall after paying or making provision for payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization operated exclusively for charitable, educational, or religious purposes as shall at the time qualify as an exempt organization under 501(c)(3) as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization as determine by the Court.
