Article I. Name

Article IV. Manner of Elections

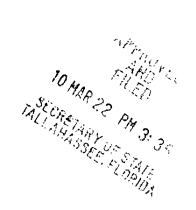
The manner in which the directors are elected:

Any such assets not so disposed of shall be disposed of by the Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization as determine by the Court.
