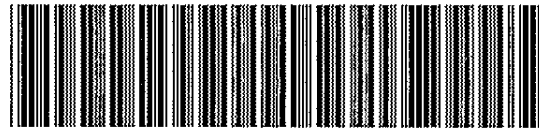

## ARTICLES OF INCORPORATION

### LIVING BY THE WORD OF GOD PRAISE & WORSHIP CHURCH OF JACKSON COUNTY, INC.

(A Corporation Not For Profit)

We, the undersigned, hereby associate together for the purpose of becoming Incorporated under the law of the State of Florida, applicable to corporations Not for profit, under the following charter:

#### ARTICLE I

The name of the corporation shall be Living By The Word of God Praise & Worship Church of Jackson County, Inc., and is to be located in Jackson County. Principal address is 3659 Kynesville Rd. Marianna, Fl. 32448.

#### ARTICLE II

The purpose for which this corporation is organized shall be that of a religious society and the general nature of the objective of the corporation shall be that of the usual Christian organization namely; to promote the Gospel of the Lord Jesus Christ. Inclusive within these purposes are the following: To preach and teach the gospel of the Lord Jesus Christ, conduct bible camps and schools, to disseminate the word of God to the people of all nations: to accept donations, contributions and gifts of all kinds of property, whether real personal or mixed, and to rent, lease, purchase or otherwise acquire, mortgage, sell or convey all kinds of property, whether real personal, or mixed, or any interest or estate therein in this state or in any of the states of the United States, territories or dependencies.

#### ARTICLE III

Any person, who has accepted Jesus Christ as his or her Saviour shall be eligible to become a member of this corporation an bylaws of this corporation.

#### **BOARD OF DIRECTORS**

Directors shall be elected as according to the by-laws.

#### ARTICLE IX

The bylaws of the corporation are to be made, altered or rescinded by the members of the corporation or as set forth on the constitution.

#### ARTICLE X

Amendments to the articles of incorporation shall be approved by the Board of Directors, proposed to them by the members of the corporation and approved at any meeting of a two-third vote of the members present, providing prior notice has been given to all corporation members of the annual meeting of the corporation.

#### ARTICLE XI

It is intended that all contributions to this organization shall be deductible for income tax purposes under section 501 © of the Internal Revenue Code.

#### ARTICLE XII

This corporation shall have the following powers:

1. To aquire real or personal property by gift, contribution bequest, devise, purchase, lease, exchange or any other manner, or to hold equitable title to real and personal property: to borrow money and issue notes, bonds, indentures and other evidence of indebttness, secured or unsecured; to sell, lease, encumber, mortgage, pledge, and otherwise deal with, acquire and dispose of real or personal property, or both, and generally perform all acts which may be expedient or proper by the corporation on the authority of its members for successful carrying out the desires and purpose of this corporation.
2. To establish and maintain missions and branch churches in Jackson County or elsewhere.
3. The members shall have the power and authority to license and ordain persons to the ministry of the Gospel of the Lord Jesus Christ and authorize them to perform the marriage ceremony.

#### ARTICLE XIII

This corporation, not for profit, is formed pursuant to the provisions of Chapter 617, Florida Statutes. 1963.
