### *ARTICLE OF INCORPORATION*



#### **ARTICLE I**

#### NAME OF CORPORATION

The name of this corporation is FAITH WORSHIP CENTER MINISTRIES, INC. It is a Florida nonprofit religious corporation.

#### **ARTICLE II**

#### LOCATION OF OFFICES

#### **ARTICLE III**

#### **PURPOSES**
