ARTICLE I

NAME OF CORPORATION

The name of this corporation is **FAITH WORSHIP CENTER MINISTRIES, INC.** It is a Florida nonprofit religious corporation.

ARTICLE II

LOCATION OF OFFICES

The principal place of business is 4868 Alamanda Drive, Melbourne, Florida 32925, Brevard County, Florida and mailing address is Post Office Box 411574, Melbourne Florida 32941-1574.

ARTICLE III

PURPOSES

This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Florida Nonprofit Religious Corporation Law exclusively for religious purposes. The specific purposes for which this corporation is organized are religious, to wit: the operation of a local church, and to have and exercise all other powers, rights, and privileges granted by the State of Florida.

ARTICLE IV

TRUSTEE/DIRECTORS

SECTION 1. NUMBER AND TERM. The number of trustees shall be no less than (3) members. The trustees shall be elected at the annual meeting of members and each trustee shall be elected to serve for a period of (3) three years or until replaced by his/her successor. One third of the members shall be elected each year. However, the Pastor may appoint trustees to the board without the approval of the church, for not more than three (3) years.
