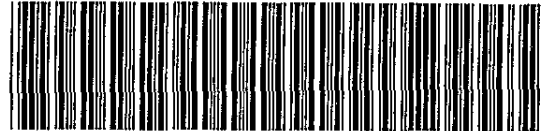

ARTICLES OF INCORPORATION
OF
BONITA SPRINGS COMMUNITY TENNIS ASSOCIATION, INC.

(A Florida Corporation Not for Profit)

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Bonita Springs Community Tennis Association, Inc.

ARTICLE II. ADDRESS

The principal place of business and mailing address of this corporation shall be 22805 Oakwilde Blvd., Bonita Springs, Florida 34135.

ARTICLE III. PURPOSE

The purposes for which this corporation is organized are exclusively for religious, charitable, scientific, literary, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE IV. MEMBERSHIP

There are to be no members in this corporation.

ARTICLE V. TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE VI. INCORPORATOR

The name and address of the incorporator of these Articles of Incorporation is Thomas F. Rizzo, 2340 Periwinkle Way, J2, Sanibel, Florida 33957.

ARTICLE VII. CORPORATE POWERS

The affairs of the corporation are to be managed by the Board of Directors. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustee, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VIII. OFFICERS AND BOARD OF DIRECTORS

The names of the officers and members of the Board of Directors who are to serve until the first election or appointment under the Articles of Incorporation shall be as shown on the attached Exhibit A.

ARTICLE IX. NUMBER OF BOARD MEMBERS

The number of persons constituting the first Board of Directors shall be three (3) and the number may be changed from time to time. Directors shall be selected as stated in Bylaws.

ARTICLE X. DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
