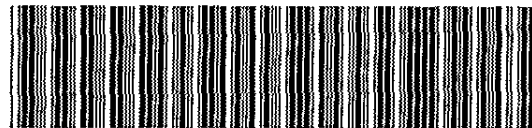



In Compliance with Chapter 617, F.S. (Not for Profit), the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation.






