The affairs of this corporation shall be managed by the Board of Trustees consisting of not less than three persons nor more than fifteen persons, having a Chair Person, a Secretary and a Treasurer (or a Secretary-Treasurer combined in one office). The Trustees shall be composed of members of the corporation of such numbers as the Corporation shall from time to time elect. The Trustees shall be elected by the members of the corporation at the annual meeting, in such manner and for such terms as shall be prescribed by the By Laws of the corporation.
