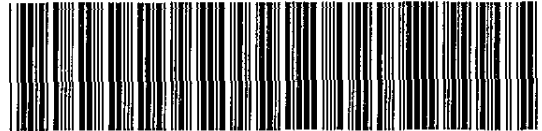

Articles of Incorporation

ARTICLE I.

NAME OF CORPORATION

The name of this corporation shall be "Saving America, Inc." It may do business under similar names as allowed by law.

ARTICLE II.

INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address for Saving America, Inc., shall be 2701 NW 23rd Boulevard, #N-117, Gainesville, Florida 32605.

ARTICLE III.

CORPORATION PURPOSES

The purposes of this corporation are charitable and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code and its valid regulations. The corporation is intended to promote social and community welfare, and reduce the burdens of citizens, landowners, local government and governmental agencies, in the the United States through growth management education, presentation, negotiation, and litigation and representation. It shall also conserve, protect and enhance the natural environment, including the human environment. The corporation may conduct other activities that its Board of Directors deems necessary or desirable to further the purposes of the corporation. Those activities must be consistent with the requirements of Section 501 (c)(3) of the Internal Revenue Code and its valid regulations. No part of the net earnings of the corporation shall inure to the benefit of any private shareholder or individual.

ARTICLE IV.

POWERS

This corporation shall have all powers which are authorized by Florida law as it presently exists and as it may be amended in the future concerning not for profit corporations.

ARTICLE V.

INCOME AND DISTRIBUTION

The corporation shall neither have nor issue any stock. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, trustees, officers, or other private persons. However, the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in the purpose clause hereof.

ARTICLE VI.

DISTRIBUTION ON DISSOLUTION OR LIQUIDATION

Upon the dissolution of Saving America, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the IRS Code, or

corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as the court shall determine, which are organized and operated exclusively for those purposes.

ARTICLE VII.

BOARD OF DIRECTORS AND METHOD OF ELECTION

The following named initial Board of Directors shall manage and direct the affairs of this corporation until their successors have been duly elected:

The method of election of directors shall be as stated in the bylaws.

ARTICLE VIII.

ARTICLE IX.

EXISTENCE

This corporation shall have perpetual existence commencing on the day of filing of Articles of Incorporation by the Florida Department of State.

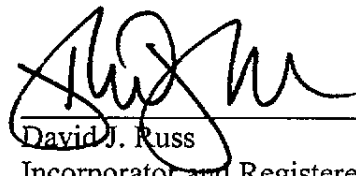
ARTICLE XI.
