The undersigned Incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act Hereby adopts the following Articles of Incorporation:

Article I

The Name of the Corporation shall be Destiny Academy II, Inc.

The period of duration of the corporation shall be perpetual.

Article III

The purpose for which this corporation is organized is to be a Childcare facility with a family and community resource center. We intend to lessen the tensions in the community by Educating the family as a whole and provide employment training. 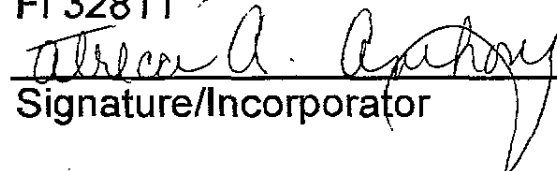

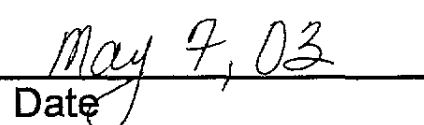
