ARTICLES OF INCORPORATION
FOR
CHI ALPHA CHRISTIAN FELLOWSHIP OF
FLORIDA STATE UNIVERSITY, INC.

The undersigned, for the purpose of filing these Articles of Incorporation according to the laws of the State of Florida, Chapter 617, Corporations Not For Profit, hereby certify:

ARTICLE I: NAME

The name of this corporation shall be:

CHI ALPHA CHRISTIAN FELLOWSHIP OF FLORIDA STATE UNIVERSITY, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSE

The purposes for which the corporation is organized are:

1. To provide students in higher education at Florida State University with Biblical Christian training, fellowship and activities.
2. To be and to make authentic disciples of Jesus Christ in the midst of the student life and culture at Florida State University.
3. To endeavor to build in the lives of the students at Florida State University a balanced approach to Christian ministry , emphasizing a 5-fold focus of ministry which is: Prayer, Discipleship, Evangelism, Worship and Fellowship and to encourage students to display each of these in their everyday lives.
4. To affiliate with the national Chi Alpha organization as a part of the Assemblies of God, 1445 Boonville Avenue, Springfield, Mo 65802.

ARTICLE IV: OFFICERS

The affairs of this corporation shall be governed by a Board of Oversight consisting of not more than three (3) members. The Chairman of the Board shall be the Campus Minister appointed to Florida State University by the national Chi Alpha office of the Assemblies of God, 1445 Boonville Avenue, Springfield, Mo 65802. The remaining members of the Board of Oversight shall be appointed by the Chairman and their terms of office shall be set forth in the by-laws of this corporation.

amended.

ARTICLE IX: INCOME AND DISTRIBUTION

No part of the income of the Corporation shall inure to the benefit of any member, trustee, director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, trustee, officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

ARTICLE X: PROHIBITED ACTIVITIES

No part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

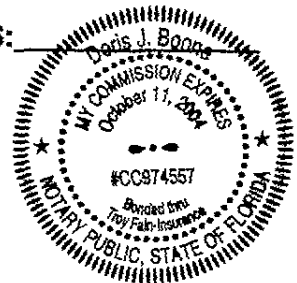

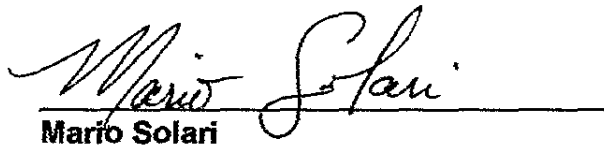
