Articles of Incorporation

A Non-Profit Corporation

The undersigned, acting as incorporators of a Corporation pursuant of Florida Statutes, adopt the following Articles of Incorporation of such corporation:

Article 1

The name of this corporation is:

### Article 3

The purposes for which this corporation is organized are:

To provide spiritual counseling, social support service and mental health referral for the Vaisnava community and others in need in North Central Florida. Services rendered will include: referral, counseling, crisis intervention, training, mediation, support for those in life's transition and relief work.


This corporation is organized exclusively for one or more of the purposes as specified in Section 501 ( c ) ( 3 ) of the Internal Revenue Code, including, for such purposes, the making of distributions or organizations that qualify as exempt organizations under section 501 ( c ) ( 3 ) of the Internal Revenue Code, or corresponding section of any future federal tax code.

### Article 4

The directors shall be chosen by a 2/3 majority vote of the directors at the annual meeting.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 ( c ) ( 3 ) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 ( h ) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal tax under Section 501 ( c ) ( 3 ) of the Internal Revenue Code or ( 2 ) by a corporation contributions to which are deductible under Section 170 ( c ) ( 2 ) of the Internal Revenue Code.
