RESOLUTION OF DISSOLUTION

HABITAT FOR HUMANITY OF FRANKLIN COUNTY, FLORIDA, INCORPORATED.,

a Florida corporation not for profit

RECITALS

1. Habitat for Humanity of Franklin County, Florida, Incorporated is a Florida corporation not for profit as defined in Chapter 617, Florida Statutes. Document number of the corporation is N03000004286.
2. The membership of the corporation do not have voting rights and no part of the corporation's assets will be distributed to any member, any person operating a for profit corporation or any other entity that would violate state law governing not for profit corporations or the Internal Revenue Code.
3. The Board of Directors determines it is in the public interest, the corporation's interest, the community served by the organization's interest and necessary to dissolve the corporation. The effective date of dissolution is June 30, 2020.

NOW THEREFORE, in consideration of the premises above which are incorporated herein by reference and acknowledged to be true and correct, the Board of Directors resolves:

- A. This Resolution is adopted pursuant to Section 617-1402(2), Florida Statutes.
- B. Mason Bean, as Vice Chairman, is designated as the person authorized to sign all documents affecting the dissolution of the corporation and the distribution of its remaining assets to an entity, not for profit, eligible to receive those assets without adverse tax consequences pursuant to the Internal Revenue Code.
- C. The Board authorizes the forgiveness of the remaining Second Mortgages encumbering the properties held by the corporation.
- D. The Board authorizes the assignment of the property owners' obligations under the First Mortgages encumbering the properties held by the corporation to Franklin County Community Development and Land Trust Corporation.

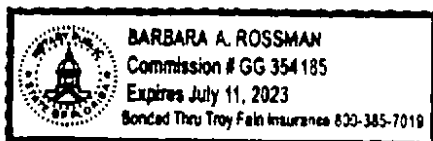
