

**ARTICLE I NAME**

The name of the corporation shall be Spirit Of Light Expo, Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be initially located at 1280 Mahogany Mill Road 19A, Pensacola, Florida 32509-3900, in Escambia County.

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is

(a) for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code,

and

(b) to organize and produce an annual Exposition in service to our community. In the creation of the "Spirit Of Light Expo," our Exposition, we define "Light" as joy, absolute joy. In the broadest sense, the Expo that we develop and produce each year is a celebration of that joy. Our intent is to create a joyful environment which brings together people of various cultural and spiritual backgrounds for emotional and physical wellness, holistic health, personal growth, mental awareness, and spiritual enlightenment,

and

(c) to provide a sense of community, through the Expo and other events, throughout the Gulf Coast and surrounding areas, by bringing together like-minded individuals and groups dedicated to the above principles,

and

(d) to promote cultural and spiritual awareness through the Expo, and other events that provide networking opportunities, for the highest good of all.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The corporation shall initially have four (4) Directors, appointed by, and made up of, the founders of the corporation. A Board of Directors shall be elected each year by a majority of the votes of the then current Board, and this election shall take place at the annual meeting, whose time and place shall be determined in the Bylaws of Spirit of Light Expo, Inc.


