Article III - Purpose (AMEND TO READ) My-My Enterprise Not For Profit Give Foundation Inc., is organized exclusively for charitable purposes. The foundation/corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes. ADD ADDITIONAL: Article VIII - MEMBERSHIP/BOARD OF DIRECTORS The foundation/corporation shall have no memberships, investments or shares. The President shall appoint all Board of Directors. No appointed director shall have any right, title, or interest in any property of the foundation. ADD ADDITIONAL: Article IX - PERSONAL LIABILITY No Officer or Director, of this foundation/corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the Officers or Directors, be subject to the payment of the debts or obligations of this corp.

ADD ADDITIONAL: Article X - DURATION

The duration of the foundation/corporate existence shall be perpetual.

ADD ADDITIONAL: Article XI - EXEMPTION REQUIREMENTS

At all times shall the following operate as conditions restricting the operations and activities of the foundation/corporation:

- 1. The foundation shall not afford pecuniary gain, incidentally or otherwise to its members. No part of the net earnings of this foundation shall inure to the benefit of any member of the foundation, except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes. The foundation/corporation shall distribute income each tax year so as not to be subject to tax on undistributed income, not engage in self-dealing, not retain excess business holdings, not make investments so as to be subjected to corporate tax and not make taxable expenditures. Such net earnings, if any, of this foundation shall be used to carry out the nonprofit corporate purposes set forth in Article III.
- 2. No substantial part of the activities of the foundation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the foundation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3. Notwithstanding any other provision of these articles, the foundation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended.

ADD ADDITIONAL: Article XII - DISSOLUTION

At the time of dissolution of the foundation/corporation, the Board of Directors shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the foundation, dispose of all of the assets of the foundation, as now enacted or hereafter amended, in such manner as the Board of Directors shall determine.
