The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt (s) the following Articles of Incorporation:

**ARTICLE I
Name of Corporation**

The Name of this Corporation shall be Women of Approach Ministries Inc.

**ARTICLE II
Principle Office**

The principle office of the corporation shall be 2802 N.W 60th Terrace #261, Sunrise, Florida 33313, County of Broward, and any other such office or place that the Board of Directors may deem from time to time as per space and facilities needed.

**ARTICLE III
Statement of Purpose**

The purpose of the organization is to assist female adults and youth through the unpleasant struggles that they may encounter due to the many forms of abuse, neglect, drug addictions, teenage pregnancy or any other ordeal which results in her needing emotional and or spiritual encouragement and assistance. To assist them with the necessary tools so that they are able cope with confidence regardless of the situation. To provide shelter, educational and employable skills training, individual and group counseling, self-esteem workshop, child care services and other related services, referrals and resources as per clients needs.

To develop and implement innovative approaches to stimulate economic development. To enhance community development through rehabilitation of existing substandard buildings and construction of new facilities in the place of blighted structures of blighted vacant sites for the purpose of combating the deterioration of the community. To contribute to the physical improvement and provide a residence for disadvantaged youth and single mothers who become homeless and in need of shelter and love for various reasons.

To assist in the process of improving the lives, living conditions for each participating client to become self-sufficient and have the confidence within to move forward in their lives.

**ARTICLE IV
The manner in which the directors are elected or appointed is:**

For the first fiscal year the board members will be elected by the choice of the Founder/Chief Executive Officer, and a general vote by the appointed board members will decide thereafter.


Provisions for Distribution of Assets
