ARTICLE I

NAME

The name of this not for profit corporation is Vicki Coceano Scholarship Fund for Miramar High School, Incorporated.

ARTICLE II

PRINCIPAL OFFICE

ARTICLE III

PURPOSE

The purpose of this not for profit corporation is to provide scholarships for higher education to graduates of Miramar High School.

ARTICLE IV

MANNER OF ELECTION

There shall be at least three but not more than five directors who shall be elected by the initial directors for terms as established in the Bylaws of the corporation.

ARTICLE V

ARTICLE VII

DISTRIBUTION OF ASSETS

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, dispose of all of the assets

of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, and scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as the court shall determine, which are organized and operated exclusively for such purposes.
