ARTICLES OF INCORPORATION

OF

THE IVAN (PUDGE) RODRIGUEZ FOUNDATION OF FLORIDA INC.

In Compliance with Chapter 617, F.S. (Not for Profit)

The undersigned sole incorporator, being a natural person competent to contract and desiring to form a corporation under the Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

THE IVAN (PUDGE) RODRIGUEZ FOUNDATION OF FLORIDA IN

ARTICLE II

The purpose for which the corporation is organized is:

To receive and maintain a fund or funds of real or personal property, or both, subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable purposes, through the establishment and maintenance, as well as the making of contributions and grants to assist in the maintenance of charitable organizations, and other such purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

ARTICLE III

The method of election of the directors of the corporation is set forth in the bylaws.

ARTICLE IV

The principal place of business and mailing address of this corporation shall be: 280 Park Avenue, 5th Fl East, New York, New York 10017.

ARTICLE V

The initial street address of the registered office of the corporation shall be and is 6385 Pinetree Drive, Miami, FL 33131, and the name of the initial registered agent of the corporation at this address is Ivan Rodriguez.

ARTICLES VI

The corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, director, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code Section 501 [h]) or participating in or intervening in (including the publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

In the event of dissolution, all of the remaining assets and property of the corporation, shall, after necessary expenses thereof, be distributed to another organization exempt under Internal Revenue Code Section 501 (c) (3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal Government, or state or local government for a public purpose.
