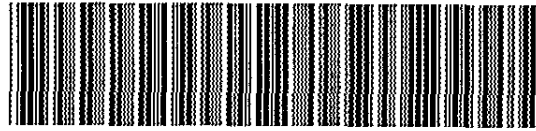

Article of AMENDMENT  
for the  
State of Florida

ARTICLE 1

The name of the corporation is: Making Ends Meet, Inc.

ARTICLE 2

The purposes for which the corporation is organized are set forth, as follows: Making Ends Meet, Inc. is a non-profit organization organized for such charitable purposes as may qualify it for exemption from the federal income tax under Section 501(c)3 of the Internal Revenue Code of 2003, as amended. More specifically, such purposes include, but are not limited to provide low income single mother financial assistance.

ARTICLE 3

The Corporation is to be financed by corporate sponsors, membership fees non-member donations, grants and net revenues from public events.

ARTICLE 4

ARTICLE 5

ARTICLE 6

The following restrictions will apply to the operations of the Corporation:

1. No part of the net earnings of the Corporation shall build up to the benefit of, or be allotted to its members, trustees, officers or other private persons, except that the Corporation shall be authorized to pay reasonable compensation for services provided and to make payments and distributions in backing of the purposes set forth in Article II.

2. No large part of the activities of the Corporation shall be the carrying on of misinformation, or else trying to pressure legislation, and the Corporation shall not participate in, or interfere in any political campaign on behalf of any candidate for public office.

3. Despite any other stipulation of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code of 2003 or (b) by a

Corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 2003

4. In the event of the closure of the Corporation, all of the Corporation's assets, real and personal, shall be dispersed to such charitable organization or organizations as are qualified as tax-exempt under Section 501(c) (3) of the Code or corresponding provisions of any subsequent Federal income tax laws, as the Board of trustees of the Corporation shall resolve.

#### ARTICLE 7

If not provided by law, a volunteer director of the Corporation is not personally liable to the Corporation or its members for financial damages for a breach of the officer's acceptable duty.

The Corporation presumes all liability to any person other than the Corporation or its members for all acts or lapses of a volunteer director acquire in good faith performance of their duty as an officer taking place on or after the date of incorporation.

#### ARTICLE 8

The bylaws of Making Ends Meet, Inc. are the final authority in matters of conflict between documents except when a stipulation of proposal to change a condition in the bylaws would cancel the legal restrictions of a nonprofit tax exempt corporation. For such a stipulation or change in a condition to be the final authority, the membership must exclusively vote to take on or withdraw the condition in question at a meeting as specified in the bylaws.
