## Articles of Incorporation Not for Profit

### Article I. Name

The name of the corporation shall be: *True Vine Worship Center, Inc.*

### Article II. Principal Office

The principal place of business and mailing address of this corporation shall be:

*454 Plymouth Road Auburndale, Fl 33823*

### Article III. Purpose

The purpose for which this corporation is organized is:

*This corporation (sometimes referred to herein as the "Church") is organized and shall be operated exclusively for religious purposes and, specifically, this corporation shall constitute a Pentecostal church the purpose and functions of which shall be as specified from time to time in the Bylaws of this corporation.*

*Within the framework and limitations of these purposes, the church is organized and shall be operated exclusively for religious purposes and shall have such powers as are consistent with the foregoing purposes, including the power to acquire and receive funds and property of every kind and nature whatsoever, whether by purchase, conveyance, lease, gift, grant, bequest, legacy, devise, or otherwise, and to own, hold, expend, make gifts, grants, and contributions of, and to convey transfer, and dispose of any funds and property and the income there from for the furtherance of the purposes of the church here in above set forth, or any of them, and to lease, mortgage, encumber and use the same, and such other powers which are consistent with the foregoing purposes and which are afforded to the church by the State of Florida. And by any future laws amendatory thereof and supplementary thereto.*

### Article IV. Manner of Election

The manner in which the directors are elected or appointed shall be:

*That a three-fourths majority rule (¾) vote be taken by active members of the church, so set forth by the bylaws of this corporation. That elections be held every four years, the day of which shall be the monthly meeting during the month of May. That all officers be eligible for re-election. That if an office becomes vacant, that the Senior Pastor hold a business meeting in the order prescribed in the Bylaws of this corporation to fill the vacancy. Voting to be carried out in democratic-style voting. That voting consist of secret ballot, cast by each active member.*
