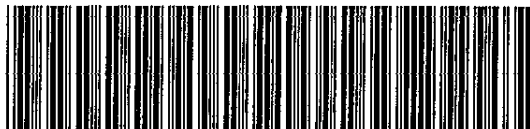

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Act, hereby adopt(s) the following Articles of Incorporation:*

### ARTICLE I NAME

In the event that a vote results in a tie, the Chairpersons vote shall decide the issue. Additional Directors shall be add to the board by majority vote.
