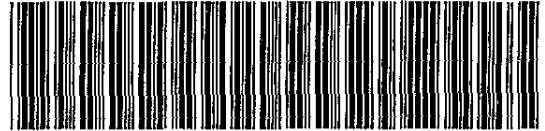

**ARTICLES OF INCORPORATION
OF
NEW CENTURY UNITED CHURCH OF CHRIST, INC.**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify that:

ARTICLE I - NAME

The name of this not-for-profit Corporation is NEW CENTURY UNITED CHURCH OF CHRIST, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business shall be 9250 Stirling Road, Hollywood, FL 33024 and the mailing address of the Corporation shall be P.O. Box 266494, Weston, FL 33326-6494

ARTICLE III - PURPOSE

The Corporation, a Church, is organized exclusively for religious, educational and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV – ELECTION OR APPOINTMENT OF DIRECTORS

The Directors of the Corporation shall be those persons chosen at the Annual Meeting of the Corporation, at such time and in such manner as more fully set forth in the By-laws of the Corporation.

The initial Board of Directors shall consist of three members. The number of directors may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one nor more than nine.
