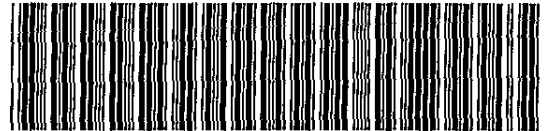

## ARTICLES OF INCORPORATION

FOR

### CROSSWAY CHURCH

The undersigned, acting as Incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of this corporation shall be CrossWay Christian Church of Osceola County Incorporated.

#### ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III. PURPOSE

The purpose for which the corporation is organized pursuant to the Not For Profit Corporation Law of the State of Florida, set forth in Chapter 617 of the Florida Statutes.

- (a) This corporation shall be a non-profit religious organization of Christians; perpetually, locally autonomous and self-controlled as to all activities, land titles and property rights; neither subservient to, controlled by, nor a member of any ecclesiastical body, society, organization or association of a governing nature.
- (b) The object of this corporation shall be that of the church as revealed in the New Testament, to win people to faith in Jesus Christ, to commit them actively to This Church, and to help them to grow in the grace and knowledge of Jesus Christ, in order that increasingly they may know and do the will of God.
- (c) This corporation is organized exclusively for charitable, religious, and religious educational purposes, including the making of distributions for such purposes to organizations, which qualify; provide facilities, opportunity, and assistance for religious education, keeping with the tenets of the New Testament and this Charter.

- (d) Notwithstanding any other provisions of this Charter, or of the bylaws of this corporation, this organization shall not, except to an insubstantial degree, engage in any activities or pursuits, or exercise any powers that are not in furtherance of these purposes of this corporation.

#### **ARTICLE IV. MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

- (a) Elders shall be appointed by the Senior Pastor and approved and affirmed by the membership.
- (b) The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Elders (Board of Elders shall be the same as Trustees until qualified Elders are appointed). The number of Elders herein provided for may be changed by a bylaw duly adopted by the members entitled to vote.
- (c) The Senior Pastor will be an Elder.

#### **ARTICLE V. INITIAL DIRECTORS/OFFICERS**

**ARTICLE VIII. BY-LAWS**

Bylaws will be adopted at the first meeting of the Board of Directors. Such bylaws may be amended or repealed, in whole or part, by the elders in the manner provided therein. Any amendments to the bylaws shall be binding on all members of this corporation.

**ARTICLE IX. AMENDMENTS OF ARTICLES**




Amendments shall be adopted by a vote of at least a two-thirds vote of the members in attendance at a properly called meeting where a quorum is present.



**ARTICLE X. DISSOLUTION**

In the event that Florida Church Planters is not in existence or is not qualified pursuant to the preceding sentence, the residual assets will be turned over to a similar Christian Church/Church of Christ Church planting organization which is so qualified.






