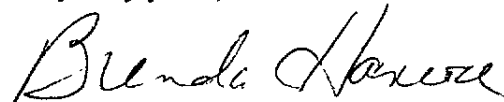

We, the undersigned, with other persons being desirous of forming a nonprofit corporation under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be **A NEW BEGINNING WITH PURPOSE, INC.** The address of the principal office of this corporation shall be 302 Courtland Circle, Lakeland, FL 33803; and the mailing address of the corporation shall be P.O. Box 1853, Auburndale, FL 33823.

ARTICLE II

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, is evangelism and other religious activities.

ARTICLE III

The manner in which the directors are to be elected or appointed is stated in the bylaws.

ARTICLE IV

The initial registered office in the State of Florida is to be located at 117 Deen Blvd., Auburndale, Fl 33823. The name of the initial registered agent of the corporation at that address is FRED BAILEY, JR.

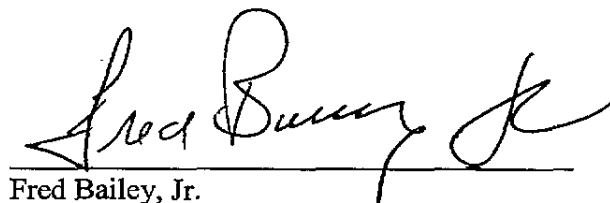
ARTICLE IX

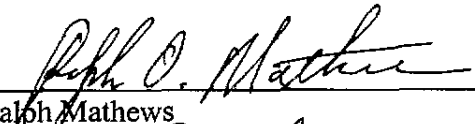
The corporation is organized, and shall be operated on a nonstock basis within the meaning of the "Florida Not For Profit Corporation Act."

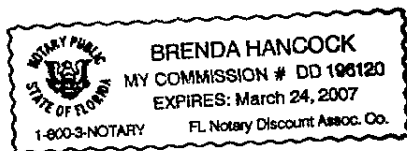

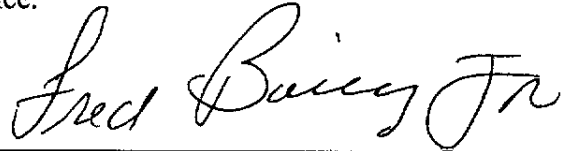
