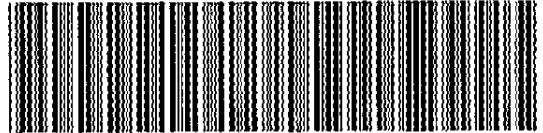

Pursuant to the provision of section 607.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following articles of amendment to its Articles of Incorporation.

FIRST: Amended adopted: Article 3. A decision was made to clarify the purpose of the corporation. The original Article 3 is deleted in its entirety. The amended Article 3 shall read:

Article 3: The specific and primary purpose or purposes for which the corporation is organized are to share and exchange religious and cultural heritage within the Hmong community and other communities. To establish and operate a culture center. To assist and encourage Hmong to become more productive community citizens. To promote higher education for Hmong children and recognize their achievement by providing college scholarship to students. To facilitate meetings and social gatherings for better relation for such purpose. To promote and exchange ideas between Hmong and other communities. To provide social service and economic development with other communities through social and business exchange and media outlet.

SECOND: The date of the amendment's adoption: January 10, 2006

THIRD: Adoption of amendment: The amendment set forth in these Articles of Amendment was proposed by the Corporation's Board of Directors and approved by the community members by vote sufficient for approval of the amendment.

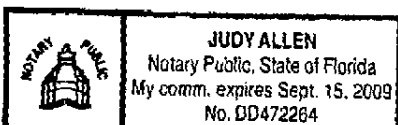
