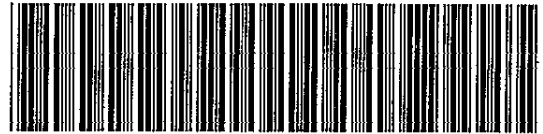

OF

AMA - FOUNDATION FOR IMMIGRANT DEVELOPMENT AND CARE, INC.
IN COMPLIANCE WITH CHAPTER 614, F.S., (NOT FOR PROFIT)

ARTICLE I - NAME


The name of the corporation shall be **AMA - FOUNDATION FOR IMMIGRANT DEVELOPMENT AND CARE, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be :
**8512 BANYAN BLVD.
ORLANDO, FL 32819**

ARTICLE III - PURPOSE

The purpose of this Corporation is to do the extended immigrant development and care, assisting all immigrants in their needs through of the all available and legal researches in the United States of America, independent of their legal status.



"Notwithstanding any other provision of these Articles, this corporation will not carry on any other activities not allowed to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any future United States Internal Revenue Law or (b) a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law".

"This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to individual, groups and or organizations under Section 501 © (3) of the Internal Revenue Code of 1954 , or the corresponding provisions of any future United States Internal Revenue Law ".

ARTICLE IV - POWER

The corporation shall be empowered to publish papers, pamphlets, newsletters, books, magazines; acquire, rent, lease, let, hold, own, buy, convey mortgage, bond, sell or assign, property real, personal or mixed, make , receive and act as solicitor of any kind of donations, as the purpose of this corporation, whether expressed or implied, shall require; associate itself with other persons, corporate or natural, for the purposes or becoming a member of, and in otherwise associating itself with other corporations, or associations, of a similar or like nature; collect dues, fees, rents, fines, subscriptions and other revenues to the advantage of corporation, and to do and perform all such other acts and things, including those generally allowed by the laws of the United States of America, State of Florida, or any State, relative to corporation not for profit, as now existing, or as the law may henceforth provide, as from time to time may necessary, or expedient in the exercises of any or all its corporate functions, powers and rights in furtherance of the exempt purposes for which it has

been organized as described in Section 501 (3) Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws.

ARTICLE V - MANNER OF ELECTION

The Board of Directors will be appointed each 04 (four) years on December 21st at main office address through annual meeting of the Board which also has the power to invite members of the community to assume positions on the Board with two-thirds majority votes of all Board effective members .

ARTICLE VI - INITIAL OFFICERS

The Board of Directors will be constituted by Executive Directors and Departments Directors. The Executive Directors are only the authorized members to represent officially the corporation , to open bank accounts, to receive and collect money on behalf of this foundation, to request grants for this foundation, to write letters on behalf of this foundation and further actions on its behalf . Each function of the Executive Directors will be disclosed at Foundation Statutes.

Amendments to Articles of Incorporation shall be adopted by a majority of the general meeting of members at any regular or special meeting called for that purpose and proposed by the Board of Executive Directors. A two-thirds majority vote of all Board members shall be necessary to amend the Articles of Incorporation.




