





We have been happy to assist Lake County Animal Control by taking in unwanted horses directly and by referral by Animal Control. We are glad to have added Lake County Animal Control to our community team a long with Last Chance Ranch, Heavenly Meadows, Pet Charities and Hoepfinger Hidden Pines.

We would like to say Thank you to Pet Smart Charities, Pet Co Foundation and Majestic Wine and Liquors who donated a total of \$3,110.00 in grant checks and fund raisers.
