ARTICLES OF INCORPORATION

OF

CROSS CREEK OF ORMOND BEACH CONDOMINIUM ASSOCIATION, INC

(A Florida Not-for-Profit Corporation)

ARTICLE I

The name of this corporation is CROSS CREEK OF ORMOND BEACH CONDOMINIUM ASSOCIATION, INC. The principal office address of the corporation shall be 227 Treeline Lane, Ormond Beach, Florida 32174. For convenience, the corporation shall be referred to in this instrument as the "Association", these Articles of Incorporation as the "Articles" and the By-Laws of the Association as the "By-Laws".

ARTICLE II PURPOSE

This Association is organized for the purpose of providing an entity under the Florida Condominium Act (the Act) for the operation of a condominium located in Volusia County, Florida, and known as Cross Creek, a Condominium (the condominium), created pursuant to the declaration of condominium (the declaration).
