ARTICLE I – NAME

The name of the corporation shall be THE CFOB PRIDE FOUNDATION, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is:

To coordinate community improvement programs that will be of benefit to the residents of the City of Ormond Beach, Florida, as well as to seek funds for such programs, related services, research and outreach efforts through public and private grants, and to develop new resources needed for the funding of programs and related services, as well as to enhance the formation of volunteer groups dedicated to proactive action in support of programs and services to improve the quality of life for Ormond Beach residents and affected persons.

ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be by majority of those voting in a mail ballot as follows:

At the regular meeting in February of each year, a nominating committee shall be appointed by the president, consisting of three members, at least one of whom shall be a board member. The nominating committee shall evaluate the qualifications of prospective candidates and present them to the board for approval at the March meeting. Space shall be provided on the ballot for write-in candidates. Clearly prepared ballots, along with a brief statement of qualifications of each candidate, shall be mailed to all members in good standing on or before the 15th day of April each year. The results of the balloting shall be announced following the election.
