THE UNDERSIGNED SUSCRIBER, to this Articles of Incorporation not-for-profit pursuant to F.S. § 617, adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be: MIAMI LAKES ROTARY CHARITABLE FUNDATION, INC. A not-for-profit Corporation.

ARTICLE II

The address of the principal office and the mailing address of the not-for-profit Corporation is:

The purpose of this no-for profit corporation is:

- (a) Said corporation/organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).
- earnings (b) No of the net οf part corporation/organization shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized. empowered to pay reasonable compensation rendered and to make payments services distribution in furtherance of section 501(c)(3) purposes. (c) Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government or to a state or local government for a public purpose.
