ARTICLE III – PURPOSE STATEMENT – AMENDMENT

The entire Purpose Statement in Article III of the Initial Articles of Incorporation shall be amended as follows:

"Harvest Bible Chapel of Jacksonville, Inc. shall have such purposes as are now or may hereafter be set forth in the Articles of Incorporation and shall be stated more specifically to spread the Gospel of Jesus Christ by the following means:

Harvest Bible Chapel of Jacksonville, Inc. is organized and operated as a not-for-profit corporation exclusively for religious purposes in accord with Section 170 (b) & (c) and Section 501(c)(3) of the Internal Revenue Code as well as Chapter 617, Florida Statutes. Harvest Bible Chapel of Jacksonville, Inc. shall have, exercise and enjoy the powers and privileges granted to corporations not-for-profit as set forth in the aforementioned code and statute. More specifically, its purpose is to be a church and to glorify God through the conduct of public worship, Bible Studies, and related religious education and Christian fellowship services designed to communicate the Gospel of Jesus Christ."

<u>ARTICLE IV – MANNER OF ELECTION – AMENDMENT</u>

The entire provision of Article IV of the Initial Articles of Incorporation shall be amended as follows:

"Officers/Directors shall be qualified for admission, and shall be admitted as Officers/Directors in accordance with the By-laws of this corporation."
