# ARTICLES OF INCORPORATION

## Of **Chargers Cheerleading Boosters, Inc.** In Compliance with Chapter 617, F.S., (Not For Profit)

### A Nonprofit Corporation

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

#### Article 1

The name of the corporation shall be Chargers Cheerleading Boosters, Inc.

#### Article 2

The principal place of business and mailing address of this corporation shall be 11033 Orange Grove Blvd, Royal Palm Beach, Florida, 33411.

#### Article 3

The purpose for which this corporation is organized exclusively is to support and encourage its members' participation in cheer competitions and foster regional, national or international sports (cheerleading) competitions.. This corporation is organized exclusively for one or more of the purposes specified in Section 501c(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 c (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Article 4


The number of initial directors of this corporation shall be three and directors are to be selected in the following manner: One director shall be appointed for the term of one year by the coaches of the Chargers in April of each year. Two directors shall be elected for the term of one year each by majority vote at the first meeting of the organization in May of each year. If for any reason there is an opening for director, replacement nominees will be selected by the Chargers coaches and election by majority vote will determine the director.

### Article 5

The Florida street address of the initial registered agent of the corporation is 738 Windflower Court, Wellington, County of Palm Beach, State of Florida, 33414, and the name of its initial registered agent at such address is Lori J. Whitaker.

The undersigned, being designated representative of the original members of the corporation, hereby certifies that the foregoing constitutes the proposed Articles of Incorporation of Chargers Cheerleading Boosters, Inc.




