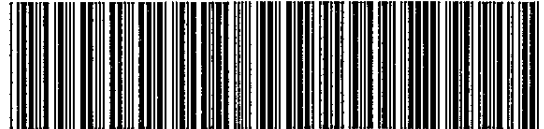

**ARTICLES OF INCORPORATION
OF
MOTORCYCLE RIDERS OF S.W. FLORIDA, INC.**
In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, for purposes of forming a corporation under the Florida Statutes 617 (Not for Profit), does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be MOTORCYCLE RIDERS OF S.W. FLORIDA, INC. The principal place of business of this corporation shall be 900 Sixth Avenue South, Suite 303, Naples, Florida 34102.

ARTICLE II. NATURE OF BUSINESS

This corporation is a group of motorcycle enthusiasts who will be taking part in riding and touring, and will engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. MANNER OF ELECTION

The manner in which the directors are elected or appointed is by a two-thirds vote.

ARTICLE IV. REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation shall be 900 Sixth Avenue South, Suite 303, Naples, FL 34102, and the name of the initial registered agent of the corporation at that address is Antonio Perez-Benitoa, Esq.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. DIRECTORS

This corporation shall have three directors initially. The number of directors may be changed from time to time in accordance with the Bylaws but shall never be less than three. The names and addresses of the initial directors of the corporation are:

ARTICLE VII. OFFICERS

The initial officer, President/Secretary/Treasurer, of the corporation is Antonio Perez-Benitoa, 900 Sixth Avenue South, Suite 303, Naples, FL 34102.

ARTICLE VIII. INDEMNIFICATION OF OFFICERS

The corporation shall indemnify any officer or director, or any former officer or director, against all liability, expenses, costs, damages and attorneys' fees reasonably incurred for any action or inaction in connection with the corporation except for gross negligence, willful misconduct, or criminal actions where the crime was not committed in a good faith or reasonable belief that the action was lawful and was not opposed to the best interests of the corporation.


An officer or director shall not be liable to the corporation for any loss or damage sustained by it for any action taken or omitted by him if he in good faith exercised the care of a prudent man, in good faith acted or failed to act based upon advice of counsel for the corporation or on the books as records of the corporation, or followed what he believed to be sound accounting and business practice.

The foregoing rights of indemnification are in addition to all other rights to which the officer or director may be entitled under law.


