On September 18, 2003, I wrote the organization a letter requesting that the organization explain how they would help people acquire computers, vehicles, and assistance for college, cleaning and repairing homes, purchasing medical and dental apparatuses, and providing educational assistance for improvement of their everyday lives. The organization response to the question was through donations to the organization of money, equipment, and people proficient in various area of expertise who are willing to donate their time. Your response did not answer the question please provide a detail description concerning each activity and the amount of time spend on each one.
2. In that same letter I requested that the organization provide the criteria to be used to help the participant of the organization. Please provide a detail descriptions of the organization criteria that will be used to help the participants.
3. In that same letter I requested that the organization provide a copy of your Articles of Incorporation that including the following provision:
 - a. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
 - b. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any

other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

- c. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The organization submitted a copy of the Articles and the By-laws the By-laws have the provision in them but, not the Articles the organization need to have the Articles amendment to put the above provisions in them.
