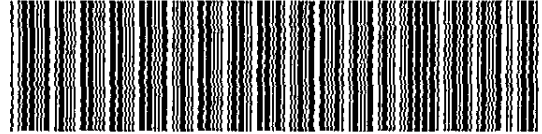

ARTICLES OF INCORPORATION  
OF  
**Fundacion Salvadoreña, Hermano, Bienvenido a Casa, Inc.**  
(A Florida Corporation, Not For Profit)

We, the undersigned, hereby form ourselves and our successors into a corporation not for profit under the corporate name of **Fundacion Salvadoreña, Hermano, Bienvenido a Casa, Inc.**, and hereby adopt the following articles of incorporation:

ARTICLE I

The name of this Corporation is **Fundacion Salvadoreña, Hermano, Bienvenido a Casa, Inc.** (hereinafter called the "Corporation").

ARTICLE II

The street address of the initial principal office and the mailing address of the Corporation shall be: 24000 Tennessee Road, Homestead, Florida 33031.

ARTICLE III

The purpose for which this corporation is organized is:

- (a) To foster, promote and encourage an appreciation of the culture and traditions of the Republic of El Salvador and its people.
- (b) To foster, promote and encourage a proper assimilation of the Salvadoran immigrants in the United States into the culture and society of the United States of America.
- (c) To make possible and promote an ease of communication between the Salvadoran immigrants in the United States and their friends and relatives in the Republic of El Salvador.
- (d) To assist and promote the economic development of Salvadoran immigrants in the United States, and to assist them to meet their economic needs and responsibilities, without regard to their race, creed or color.
- (e) To receive, administer, disburse and invest gifts, devises and bequests by or from any person or corporation for the promotion of the above purposes.
- (f) To buy, sell, lease, build, construct, erect, maintain and equip offices or buildings to carry out the above purposes, and to issue bonds, notes, debentures and evidences of indebtedness and to secure the same by mortgage, security agreement, deed of trust or otherwise.

ARTICLE IV

Management of the Corporation shall be vested in the Corporation's Board

of Directors, the members of which shall be not less than three. The number and method of election of the directors of the Corporation who shall serve following the terms of the initial directors of the Corporation shall be as stated in the bylaws; except that the third member of the first Board of Directors will be appointed by the incorporator of this corporation prior to the initial meeting of said Board of Directors.

#### ARTICLE V

The term for which this Corporation shall exist shall be perpetual.

#### ARTICLE VI

The Bylaws of this corporation shall be made, altered or amended, by a majority vote of the Board of Directors of the Corporation, at any regular or special meeting duly and regularly called by the Board or any Director.

#### ARTICLE VII

Upon written or oral notice, the Articles of Incorporation may be amended, altered, or rescinded by a four-fifth vote of the Board of Directors of the Corporation, in accordance with procedures established by the Bylaws.

#### ARTICLE VIII

The street address of the initial registered office of the corporation is 24000 Tennessee Road, Homestead, Florida 33031; and the name of its initial registered agent at such address is: Scott Jesse Silver.

#### ARTICLE IX

The name and address of each incorporator of the corporation is:

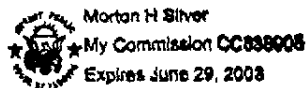
