The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be MACKEY COVE HOMEOWNERS' ASSOCIATION, INC.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 3687 Mackey Cove Drive, Pensacola, Florida 32514.

ARTICLE III

PURPOSE

The specific purpose for which the corporation is organized is to create and maintain a homeowners association to govern and provide services to the residents of Mackey Cove Subdivision, Escambia County, Florida.
