**ARTICLES OF INCORPORATION
FOR
FAITH TABERNACLE FIRST BORN CHURCH OF SOUTH MIAMI INC.**

The undersigned subscriber(s) of these Articles of Incorporation, natural persons(s) competent to contract hereby form a corporation under the laws of the State of Florida.

ARTICLE 1 - NAME

The name of the corporation is
FAITH TABERNACLE FIRST BORN CHURCH OF SOUTH MIAMI INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be
6141 S. W. 64TH Street, south Miami Florida 33143

ARTICLE III- TERM OF EXISTENCE

The term of existence of this corporation shall be perpetual.

ARTICLE IV- PURPOSE

This corporation is organized for general corporate purposes, and for the purpose to facilitate and execute the business and activities of the **FAITH TABERNACLE FIRST BORN CHURCH OF SOUTH MIAMI INC.** Within the State of Florida and meet the requirements of the laws of the State of Florida in regard to the acquiring, mortgaging and disposition of real estate within the State of Florida and to conduct any and all business of the corporation with regard to ownership of property for the **FAITH TABANACLE FIRST BORN CHURCH OF SOUTH MIAMI INC.**, and its members. Its further purpose is to carry on and to promote in a cooperate way the Evangelistic, education and religious work of the corporation. To collect, solicit and accept funds, gifts and other subscriptions, to hold in trust, use mortgage, lease, sell or otherwise acquire or dispose of property, real or chattel, in keeping with the recited purpose of this corporation and it shall have exercise all powers that are necessary or convenient to effect any and all of the purpose which this corporation is organized. To provide for preaching, teaching and fostering the growth of the Christian religion in all places; to license and ordain ministers, to license and ordain deacons and missionaries.

ARTICLE V- MEMBERS

Any person who subscribes to and accepts the Covenant of Membership, the teaching and the manner of church government as outlined by the Holy Scriptures may be a member of this corporation. The corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered

to pay reasonable compensation for services rendered and make payment and distributions in furthermore of the purposes set forth in this article. No substantial part of this corporation shall be the carrying on of propoganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities and permitted to be carried on by a corporation exempt from federal income tax under Section 501©(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law, or by a corporation, contributions to which are deductible under Section 170©(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Code. On the dissolution of this corporation the board of Trustee shall dispose of all of the assets of this corporation exclusively for the purpose of this corporation to an organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes and that qualify as exempt organizations under Section 501©(3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States International Revenue Code, after paying or making provisions for the payment of all liabilities of this corporation.
