ARTICLES OF AMENDMENTS ARE AS FOLLOWS:

ARTICLE III - PURPOSE

- a) The said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- b) For establishing and maintaining an organization of fellowship to share the responsibility and privilege of propagating the gospel of Jesus Christ.

ARTICLE VIII

a) No part of the net earnings of the corporation shall insure to the benefit of or be distributable to it's members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make the payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the actives of the corporation shall be the carry on of propaganda, otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, to the corresponding section of any future federal tax code.

ARTICLE IX

a) Upon dissolution of the corporation, assets shall be distributed to a church of like faith for one or more exempt purposes within the meaning of section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such exclusively for such purposes.
