The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, hereby associate themselves together for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Florida, with and under the following Articles of Incorporation.

ARTICLE I

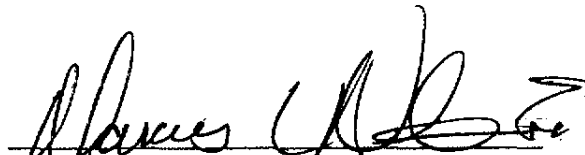
ARTICLE VIII
