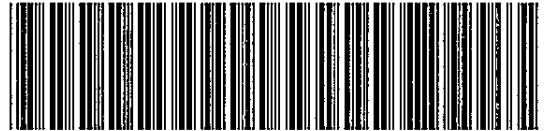

Articles of Incorporation
For
High Sounding Cymbals, Inc.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

Article I

The name of the corporation shall be:
High Sounding Cymbals, Inc. (the "Corporation").

Article II

The principal and mailing address of this corporation is:

Article III

The Corporation is a Florida Corporation. The Corporation is organized exclusively for religious, charitable and educational purposes in the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IV

The manner in which the directors are elected/appointed is as follows: The initial directors of the Corporation shall be appointed by the registered agent; thereafter, the directors shall serve a term of 3 years upon which their seat will be subject to re-election by majority vote of the board.

The corporate powers of the corporation are provided as follows: Notwithstanding any other provisions of these articles, this corporation shall not carry on any activities not permitted to be carried in by an organization exempt from Federal income tax under the 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The corporation shall not have members.

Article IX

The effective date of these articles of incorporation is the filing date registered with Florida Department of State, Division of Corporations.

Article X

No part of the net earnings of the Corporation shall benefit any director or officer of the Corporation. The corporation may hire a director or officer as an employee of the Corporation and pay that individual reasonable compensation for services rendered and may make distributions in furtherance of the purposes set forth in Article III.

In the event of the dissolution of the Corporation, the assets of the Corporation shall be distributed to one or more entities organized and operated for religious, charitable, and educational purposes and described in Sections 170 (c)(2) and 501 (c)(3) of the Internal Revenue Code.
