

# ARTICLES OF INCORPORATION (NON-PROFIT)

Of

REVELATION CHURCH OF GOD BY FAITH INC.

In Compliance with Chapter 617,F.S. of the Not-for-Profit Corporation Law IT IS HEREBY CERTIFY THAT:

## **ARTICLE I NAME**

The name of the corporation is REVELATION CHURCH OF GOD BY FAITH INC.

ARTICLE II PRINCIPAL OFFICE

The office of the Corporation Revelation Church of God, is is to be located at 240 North Lakeshore Way, in the City of Lake Alfred, County of Polk, and the State of Florida.

The territory in which the activities of the corporation are principally to be conducted is the Continental United State of America.

## **ARTICLE III PURPOSE**

The purposes for which the corporation is formed are as follows:

To undertake the spreading of religious gospel and religious messages and education in Haitian Creole, in French or English through any medium practicable, whether by radio, television, publications, personal contacts, or otherwise; to engage in prayer activities and religious ministry to the sick, the general public and Church members. Our schedule of worship will be: Sunday school 10AM to 11AM, Sermon 11AM to 12AM. Evangelization, 7PM to 9PM. Wednesday, Prayer meeting 7PM to 9PM. Thursday, 8PM to 12PM, Testimony Night.

The corporation, in furtherance of its corporate purposed above set forth, shall have all the powers enumerated in Chapter 617 Florida Statutes of the Not-for-Profit Corporation Law, subject to any limitations provided in the Not-for-Profit Corporation Law or any other statute of the State of Florida. Nothing herein shall authorize this corporation, directly or indirectly, to engage in, or include among its purposes, any of the activities forbidden in Not-for-Profit Corporation Law.

#### ARTICLE IV MANNER OF ELECTION

#### **ARTICLE VII**

## State and Federal exemption language for Type B and C corporations seeking tax exemption.

Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes as specified in §501(c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under IRC§501(c) (3) or corresponding provisions of any subsequent Federal tax laws.

No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by IRC§501(h)] or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.

In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC§501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.

In any taxable year in which the corporation is a private foundation as described in IRC\$509(a), the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under IRC§4942, and the corporation shall not (a) engage in any act of self-dealing as defined in IRC§ 4941(d), retain any excess business holdings as defined in IRC§4943(c), (b) make any investments in such manner as to subject the corporation to tax under IRC§4944, or (c) make

Any taxable expenditures as defined in IRC§4945(d) or corresponding provisions of any subsequent Federal tax laws.
