The corporation is organized as a church exclusively for religious, charitable, and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the evangelizing of the unsaved by the proclaiming of the gospel of the Lord Jesus Christ, the educating of believers in a manner consistent with the requirement of Holy Scriptures, the maintaining of missionary activities in the United States and any foreign country, and any other lawful purpose or purposes not for profit and not specifically prohibited to corporations under other laws of the state of Florida.

Upon the dissolution of the corporation, the board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, religious ,or educational purposes as shall at the time qualify as an organization exempt from federal income taxation under section 501 (c) (3) of the Internal revenue Code of 1986 (or the corresponding provision of any future United States internal Revenue Law), as the Board of Directors shall determine.
