The undersigned, acting as founder and Incorporator of a Corporation pursuant to chapter 617, of the Florida Statutes, adopt the following Articles of Incorporation for such Corporation on May 27, 2003 in Miami, Dade County, Florida.

Article I

The name of this Church shall be "INTERNATIONAL HOLY-GHOST CONFERENCE INC"

Article II

This Church is located at 680 NW 71st Street Miami Florida 33150

Article III

The purposes for which the Corporation is organized are:

1. To preach and Teach the Gospel of our Lord and Saviour Jesus Christ according to the interpretation given in the By-Laws of this Corporation.
2. To Incorporate other Churches to our Corporation, included but not limited to Missions.
3. To Ordaine Ministers.

Article IV

The duration of this Corporation shall be perpetual, unless dissolved only by the President.

Article X

This Corporation will be directed and administered by the Pastor of the Church who shall be the President of the Corporation.

The Pastor will designate a Ministerial Body to assist him with the Spiritual aspect of the Church, such Body will consist of: Elders, Deacons, Ministers, and Ministries.

Article XI

In the event of dissolution, the residual assets of the Corporation will be turned over to one or more Corporations which are exempt as Corporations described in Section 501-C-3 and 170-C-2 of the Internal Revenue Code of 1954 or corresponding Sections of any prior or future Law, or to the Federal State or Local Government for exclusive public purpose.


Article XII

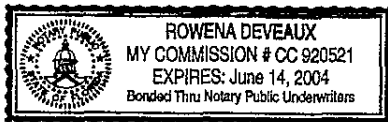
