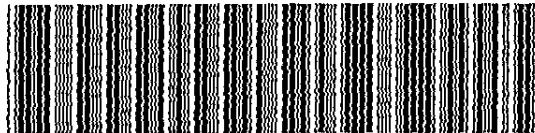

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Chipola Area Gators, Inc. The principal address of the corporation at the time of incorporation is 4450 Lafayette Street, Marianna, Jackson County, Florida.

ARTICLE II - ENABLING LAW

This corporation is organized solely pursuant to the Florida Not for Profit Corporation Act, set forth in Chapter 617 of the Florida Statutes.

ARTICLE III - TERM OF EXISTENCE

This duration of this corporation is perpetual unless dissolved according to law.

ARTICLE IV - GENERAL AND SPECIFIC PURPOSES

The purposes for which this corporation is organized are:

(a) To unite the graduates and supporters of the University of Florida, in order to promote and cultivate closer professional relationships and good fellowship among the graduates and supports of the University of Florida.

ARTICLE V - POWERS

The powers of the corporation shall be as enumerated in the Florida Not for Profit Corporation Act (Fla. Stat. §617.0302) and shall include, but not be limited to, the following:

(a) To receive property by devise or bequest, subject to the laws regulating the transfer of property by will, and to otherwise acquire and hold all property, real or personal, including securities of other corporations.

(b) To act as trustee under any trust, incidental to the principal objects of the association, and to receive, hold, administer, and expend funds and property subject to a trust or trusts.

( ) To convey, exchange, lease, mortgage, encumber, transfer on trust or otherwise dispose of all property, real or personal.

(d) To borrow money, contract debts, issue bonds, notes and debentures, and secure the payment or performance of its obligations.

(e) To do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of the association.

## ARTICLE VI QUALIFICATION AND ADMISSION OF MEMBERS

The powers, duties and privileges of the members of the corporation, and the manner of their admission, shall be as specified in the bylaws of the corporation. All provisions in these articles of incorporation, or in the bylaws of the corporation, for the bylaw and conduct of the affairs of the corporation and the qualifications for membership in the corporation are expressly intended to be in furtherance, and not in limitation or exclusion, of the powers conferred by statute.

## ARTICLE VII INTERESTED DIRECTORS OR OFFICERS

No contract or other transaction between the corporation and any other firm, association, or corporation shall be affected or invalidated by reason of the fact that any one or more of the directors or officers of the corporation, is or are interested in, or is a member, director, or officer, or are members, directors, or officers of any other firm or corporation. Any director or officer, individually or jointly, may be a party or parties to, or may be interested in, any contract or transaction of this corporation or in which this corporation is interested, and no contract, act, or transaction of this corporation with any person or persons, firm, association, or corporation, shall be affected or invalidated by reason of the fact that any director or directors or officer or officers of this corporation is a party or are parties to, or interested in, the contract, act, or transaction, or in any way connected with the person or persons, firm, association, or corporation. Each person who may become a director or officer of this corporation is relieved from any liability that might otherwise exist from contracting with this corporation for his or her benefit or for the benefit of any firm, association, or corporation in which he or she may be in any way interested.

## ARTICLE VIII - REGISTERED OFFICE AND REGISTERED AGENT

The street address of the corporation's initial registered office is 4450 Lafayette Street, City of Marianna, County of Jackson, Florida, and the name of the corporation's initial registered agent at that address is H. Matthew Fuqua, Esq.

## ARTICLE IX - FIRST BOARD OF DIRECTORS

Not less than three persons shall serve the corporation as directors until the first annual meeting or other meeting called to elect directors.

Bylaws will be adopted at the first meeting of the board of directors. The bylaws may be amended, repealed, in whole or in part, by the board of directors in the manner provided in the bylaws. Any amendments to the bylaws shall be binding on all members of this corporation.

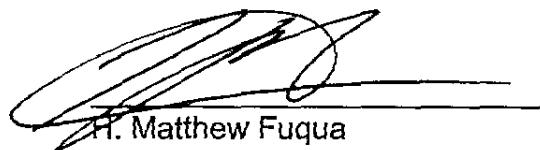
## ARTICLE XII - AMENDMENT OF ARTICLES

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of the voting members for their vote. Amendments may be adopted by a vote of at least two-thirds of a quorum of the voting members of the corporation.

### ARTICLE XIII - DISTRIBUTION ON DISSOLUTION

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) or 170(c)(2) of the Internal Revenue Code or corresponding sections of the Code as subsequently amended, or to the federal, state, or local government to be used exclusively for public purpose.

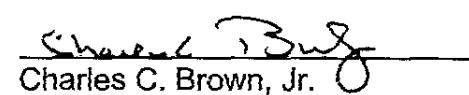

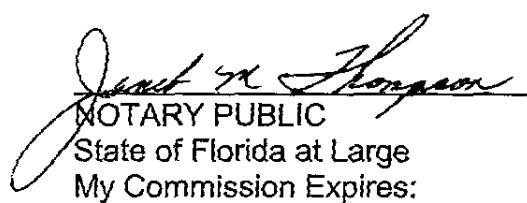

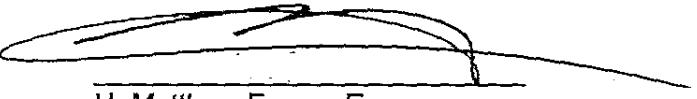
