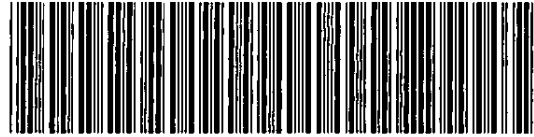

Pursuant to section 617.1402 - 1403 of the Florida Statutes, this corporation submits the following articles of dissolution:

1. The name of the corporation is **Evangelical Presbyterian Church, Inc.**, and;
2. The effective date of dissolution is August 31st, 2009 and;
3. The corporation has no members and the dissolution was approved by the board of directors on July 14, 2009 and July 24th, 2009. The number of votes cast for dissolution was sufficient for approval, and;
4. That all liabilities and obligations of the corporation have been paid or discharged or that adequate provision has been made therefore, and;
5. That all remaining property and assets of the corporation have been distributed in accordance with its articles of incorporation to **Coral Ridge Presbyterian Church, Inc.**, a 501(c)3 entity, and;
6. That there are no actions pending against the corporation in any court or that adequate provision has been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending action.

On July 14, 2009 and July 24th, 2009 the board of directors of **Evangelical Presbyterian Church, Inc.**, a Florida Not-For-Profit corporation met for the purpose of approving the dissolution of the corporation pursuant to F.S.S. 617, Sections 1402 and 1403 and approved the effective date of the dissolution of the corporation as of August 31, 2009. Each member of the Board of Directors was given proper notice of the meeting and a quorum was present. Each member of the Board of Directors also executed a consent to action approving the action taken at each of the meetings.

After discussion, a motion was duly made and seconded and the following resolutions were unanimously approved.

RESOLVED: That all liabilities and obligations of the corporation have been paid or discharged or that adequate provision has been made therefore; and

FURTHER RESOLVED: That all remaining property and assets of the corporation shall be distributed to **Coral Ridge Presbyterian Church, Inc.**, a 501(c)(3) entity, in accordance with the corporation's article of incorporation; and

FURTHER RESOLVED: That there are no actions pending against the corporation in any court or that adequate provision has been made for the satisfaction of any judgment, order or decree which may be entered against it in any pending action; and

FURTHER RESOLVED: That upon the effective date of the dissolution the corporation will have no outstanding business and have no remaining assets or debts or that adequate arrangement for the payment of any remaining debts will have been made. That the dissolution of **Evangelical Presbyterian Church, Inc.** pursuant to F.S.S. 617.1402 - 1403 is formally approved effective August 31st, 2009 and the president of the corporation is authorized to file the appropriate documents with the state of Florida, Secretary of State, Division of Corporations to effectuate the dissolution.

There being no further business before the Board, a motion was made to adjourn. The motion was seconded and approved.
