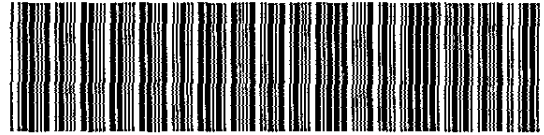

**ARTICLES OF INCORPORATION
OF
MASTER SAVIOR REDEEMER MINISTRIES, INC.**

Article 1. Name. The name of the Corporation is: **Master Savior Redeemer Ministries, Inc.**

Article 2. Duration. The duration of **Master Savior Redeemer Ministries, Inc.** is perpetual.

Article 3. Purposes. The purpose of **Master Savior Redeemer Ministries, Inc.** is as follows:

A. **Master Savior Redeemer Ministries, Inc.** is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to conduct any lawful business not for pecuniary profit and not specifically prohibited to corporations under the Florida Statutes.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that **Master Savior Redeemer Ministries, Inc.** shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of **Master Savior Redeemer Ministries, Inc.** shall inure to the benefit of or be distributable to its members, directors, or officers; but **Master Savior Redeemer Ministries, Inc.**, authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. **Master Savior Redeemer Ministries, Inc.** shall have no Voting Members. The Bylaws may provide for Nonvoting Members, of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.

Article 5. Initial Registered Agent and Office. The initial registered agent is **Rev. Marcus Rego** and the initial registered office **6817 NW 32 CT, Margate, FL 33063.**

Article 6. Initial Board of Directors. The initial Board of Directors shall have 3 members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.

Article 7. Officers. The Officers of **Master Savior Redeemer Ministries, Inc.** shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors, and may be removed by the Board of Directors, at such time and in such manner as may be prescribed by the Bylaws. 
