ARTICLES OF INCORPORATON OF REACHING ONE NATION, INCORPORATED

AKTICLE I - Name and Address

The name and address of this principal corporation is Reaching One Nation, Incorporated

West Palm Beach, FL 33407, in Palm Beach County. The corporation is organized pursuant to the Florida-Nonprofit Corporation Code.

ARTICLE II - Nonprofit Provisions and Purposes

- (A) This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of selfsufficiency.
- (B) The main objective of Reaching One Nation, Incorporated is to serve as a community based organization, to empower economically distressed communities by providing affordable housing to low to moderate income residents, while providing job and life skills training; to promote revitalization and stimulate investment in disadvantaged economical areas.
- (C) Programs of Reaching One Nation, Incorporated will consist of but shall not be limited to: educational opportunities, life skills, music engineering and producing, job placement, land acquisition, employment, literacy, counseling, temporary shelter, teenage pregnancy, substance abuse awareness and prevention, tutoring, healthcare initiatives, child care, elderly care, consulting and other programs to aid those in need.
- (D) The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

ARTICLE III - Corporate Duration

The corporation shall have perpetual existence.

ARTICLE IV - Registered Office and Agent

The address of the Registered office is: 3516 Broadway, West Palm Beach, FL 33407, and the name and address of the registered agent of the corporation shall be:

ARTICLE V - Corporate Nature

- (A) The corporation is organized and operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.
- (B) Not-withstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation's contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

ARTICLE VI - Initial Directors and Officers

The directors are elected in accordance with the Bylaws. However, there shall never be less than three (3) individual Directors. The Board of Directors may amend these Articles of Incorporation as it may deem necessary for the conduct of its business and the carrying out of its purposes. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
