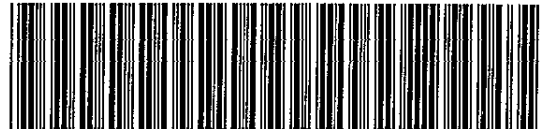

ARTICLE I.

Name: The name of the corporation shall be: Spinal Cord Tumor Association, Inc.

ARTICLE II.

ARTICLE III.
